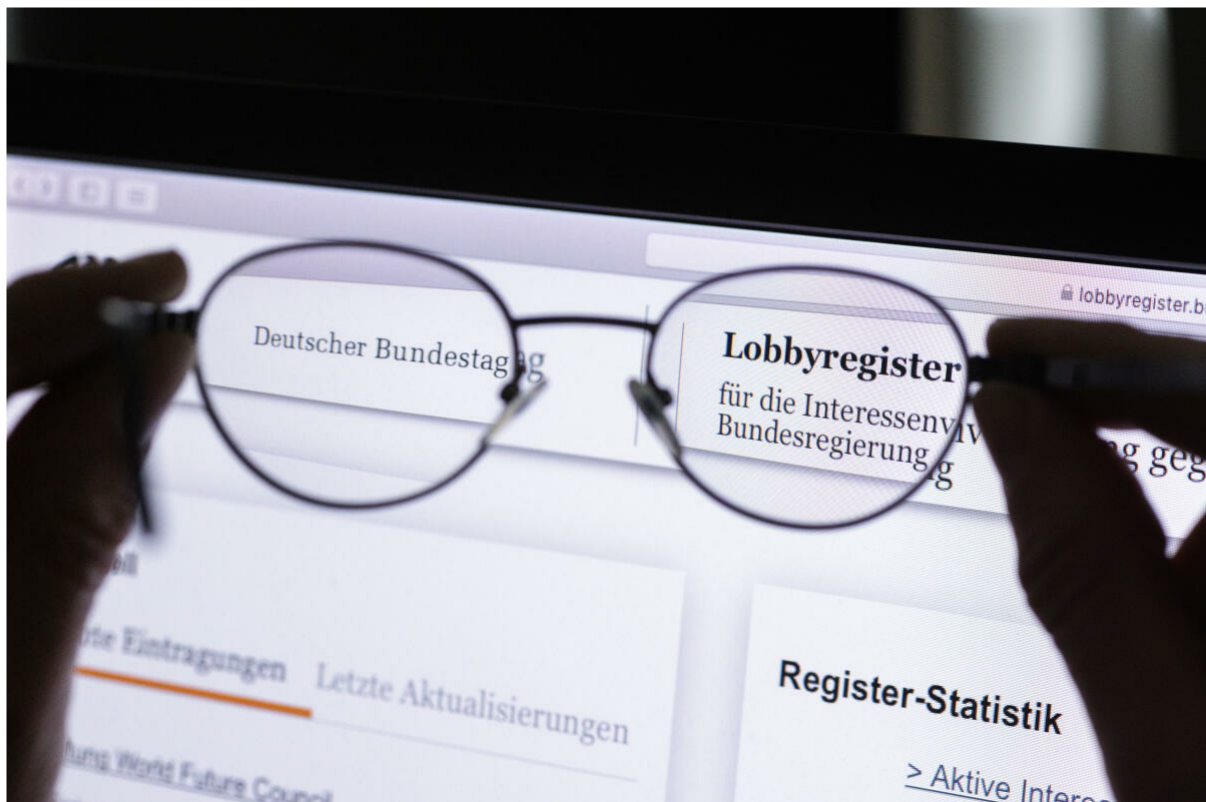

## Introduction

The communication of interests from different parts of society to politicians is an inherent characteristic of any democracy. However, the public should be able to identify who seeks to influence political and legislative decisions and on whose behalf, using what financial and human resources and with what objectives and arguments.

That is why the Lobbying Register for the representation of special interests vis-à-vis the German Bundestag and the Federal Government was introduced in 2022. It is intended to help strengthen trust in the legitimacy of democratic processes and institutions.

The Lobbying Register is publicly available via the following internet address:

[lobbyregister.bundestag.de](https://lobbyregister.bundestag.de)

It already contains more than two million data points on the various lobbyists, their structural and financial backgrounds and, above all, their objectives and arguments. With its extensive search, sorting and filtering functions, it offers wide-ranging options for the general public, the press and media, researchers and politicians and, not least, lobbyists themselves to search for the information they want.

The enormous wealth of data in the Lobbying Register is an outstanding source of first-hand data regarding many social and political debates on the most diverse of issues.

### Lobbyregister

Die Vertretung gesellschaftlicher Interessen gegenüber der Politik gehört zu den Wesensmerkmalen einer jeden Demokratie. Das Lobbyregister ermöglicht es, Strukturen und Inhalte der bezweckten Einflussnahme durch Interessenvertreterinnen und Interessenvertreter auf die Willensbildungs- und Entscheidungsprozesse des Deutschen Bundestages und der Bundesregierung nachzuvollziehen. Bürgerinnen und Bürger sollen erkennen können, wer, in wessen Auftrag, mit welchen personellen und finanziellen Aufwendungen und mit welchen Zielen und Argumenten Einfluss auf politische und gesetzgeberische Entscheidungen nehmen will. Durch die gesteigerte Transparenz in diesem Bereich soll das Lobbyregister dazu beitragen, das Vertrauen in die Legitimität demokratischer Prozesse und Institutionen zu stärken.


## 1. The home page

The [Lobbying Register home page](#) provides important **fundamental and statistical information** at a glance:

- **How many** people and organisations are currently engaged in lobbying?
- What **type of organisation** are they (fields of activity)?
- What is the **subject matter** of the lobbying (areas of interest)?
- Which **entries** have been **recently added** and which have just been **updated**?
- For how many of the people named are there indications of a “**revolving door effect**” (having worked for the Bundestag, Federal Government or the federal administration in the last five years)?
- Who has **failed to update** their register entry in good time or **infringed the Code of Conduct**?
- Which **former representatives of special interests** are no longer engaged in lobbying requiring registration?


## 2. Detailed information about the lobbying landscape

Detailed information about the **lobbying landscape** at the federal level can be obtained by leaving the search box on the home page blank and **simply clicking [search](#)** (“*Suchen*”).

That methods can be used, for example, to answer the following questions:

- Who has spent the **most money** on lobbying? (Sort by financial expenditure (highest first) (“*Höhe der finanziellen Aufwendungen (absteigend)*”).)
- Who has registered **the greatest number of specific objectives and intentions** in relation to the amendment, creation, repeal or retention of particular regulatory provisions? (Sort by number of regulatory proposals (highest first) (“*Regelungsvorhaben, Anzahl (absteigend)*”).)
- Who has uploaded the **most comments or expert opinions** to the Register? (Sort by number of comments (highest first) (“*Stellungnahmen, Anzahl (absteigend)*”).)
- Who has employed the most people in lobbying? (Sort by number of employees (highest first) (“*Beschäftigte, Anzahl (absteigend)*”). The results will be given in terms of full-time equivalents.)
- Who has registered the most people who are not just occasionally tasked with the representation of special interests? (Sort by number of **people tasked** (highest first) (“*Betraute Personen, Anzahl (absteigend)*”).)
- Who has registered the most lobbying **commissions**? (Sort by number of commissions (highest first) (“*Aufträge, Anzahl (absteigend)*”).)
- Which organisation has most **members**? (Sort by number of members (highest first) (“*Mitglieder, Anzahl (absteigend)*”).)
- Who has received the largest sum in **membership dues**? (Sort by total of membership dues (highest first) (“*Mitgliedsbeiträge, Gesamtsumme (absteigend)*”).)
- Who has received the **highest total in gifts** and other lifetime donations from third parties? (Sort by gifts, donations (highest first) (“*Schenkungen, Gesamtsumme (absteigend)*”).)

### 3. Narrowing down search results

#### using facet filters

That comprehensive list of all entries can then be narrowed down using the **facet filters**.

These can be used, for example,

- to show only **entries by companies** (of particular legal forms), **associations** or **non-profit organisations** working for a particular area of special interest;
- to show only entries from those **commissioned by third parties** to engage in lobbying;
- to show only entries containing references to **regulatory proposals** to amend, create, repeal or retain particular legal provisions or publishing **essential written comments and expert opinions**;
- to show only entries containing people in relation to whom there are indications of a **revolving door effect**;
- to filter by **main sources of financing** (“*Hauptfinanzierungsquellen*”) in order to find entries from organisations primarily funded by economic activity, membership dues, state subsidies or gifts;
- to search the register as it was on a particular **date in the past**, to see, for example, who was actively engaged in lobbying when a particular act was passed.

The **filters** can also be freely **combined**, so that you can always quickly find the particular constellation of lobbyists you are looking for.

#### 4. Searching for specific organisations, names or terms

It is, of course, also possible to find a specific **register entry**, or search for individual words or parts of words, directly from the home page, by entering certain search terms or a register number (if known) in the free-text search box.

To further narrow down the search results, queries can use the **Boolean operators** you may know from other databases, such as **AND** (“*UND*”), **OR** (“*ODER*”) and **NOT** (“*NICHT*”).

All the information in all entries is then searched for hits, and the search terms found are highlighted in the list of search results. From there, of course, you can further narrow down the results using the **facet filters**.

If the search results are still too numerous, another possibility is to select [register entries](#) (“*Registereinträge*”) from the main menu to access **more refined search options**. These allow you to specify that the search term should appear **only in certain categories within the entries**.

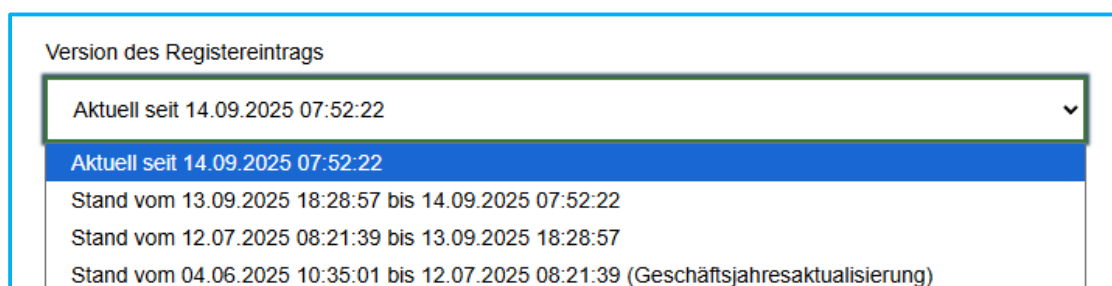

### **5. Diverse information in individual register entries**

Calling up the register entry of a particular company, association or other organisation will often reveal very extensive information on the lobbyist concerned. Such a register entry comprises several **categories**:

- **Structural information:**  
Contact details, legal form, names of all authorised representatives and persons entrusted with lobbying, total number of members, own memberships, office in the capital
- **Financial information:**  
Main sources of financing, annual financial expenditure involved in the representation of special interests, allowances and grants from the German public purse, gifts and other lifetime donations, membership dues, annual accounts or management reports
- **Information on any contractual relationships:**  
Information on the identity of clients and sub-contractors and the commissions awarded, particulars of the financial resources received from clients
- **Information on the substance of the lobbying:**  
Regulatory proposals in regard to which the representation of special interests is carried out and the associated essential comments and expert opinions

In addition to the current version of each register entry, **historical versions of each entry** can be accessed from the past **18 months**. Those **historical versions** constitute a kind of public **archive** and depict how a register entry has evolved and when which information was added or removed.



Information on regulatory proposals and comments or expert opinions even remain accessible on the **substance of lobbying** pages for **eight years** following their removal from a register entry (see "[Fehler! Verweisquelle konnte nicht gefunden werden.](#)" below).

## 6. Searching for particular people and the advanced search function

One particularly user-friendly feature is the [search for individuals](#) (“*Personensuche*”). As soon as at least three letters of a forename or surname are typed in one of the search boxes, suggestions are offered from the database, making it easy to quickly find the entries in which that person’s name appears. Here, too, the search can be refined to certain categories within the entries, such as authorised representatives (“*vertretungsberechtigte Personen*”).

An advanced search function (“*Expertensuche*”) is also provided. This feature allows for targeted research. Search results are displayed which both contain the search terms specified and fit the selected filters.

## 7. Substance of the lobbying

Since the reform of the Lobbying Register Act (*Lobbyregistergesetz*) which came into force on 1 March 2024, a wide range of information can be found in the register on **lobbyists' specific objectives and arguments**.

These are recorded within the register application using a structure which makes it possible to identify

- which specific **regulatory proposals** (referring to the amendment, creation, repeal or retention of particular legal provisions) each lobbyist is pursuing and
- who is representing special interests in connection with specific legislative bills (ministry drafts and Bundestag or Bundesrat printed papers) or federal laws and **with what objectives and arguments**.

The starting point for such searches is the **substance of lobbying** section of the Lobbying Register application, which is reached via "[\*Inhalte der Interessenvertretung\*](#)" in the main menu.

The [front page of the substance of lobbying](#) section provides a good overview of the types of information to be found there. These include, for example,

- the current **total number of regulatory proposals registered by lobbyists**,
- the current **total number of comments/expert opinions uploaded** and
- statistics regarding the **spread of lobbying activities across areas of interest**, the various parts of the federal government and **target groups** within the Bundestag.
- You can also simply **scroll through** all regulatory proposals and comments in the register, starting with the most recently added. This makes it easy to identify on what issues lobbyists are currently engaged.

The search function in the substance of lobbying section is similar to the home page search, but it offers the additional option of searching for a particular keyword, printed paper number or other search term **only in certain categories**. There are **four search areas**:

- **Regulatory proposals** (“*Regelungsvorhaben*”): This refers to the **objectives and intentions** registered by each lobbyist in connection with the specific legislation to which they relate.
- **Comments / expert opinions** (“*Stellungnahmen/Gutachten*”): This is a full-text search which directly scans all the written contents of the comments and expert opinions provided.
- **Regulatory drafts** (“*Regelungsentwürfe*”): Here you can search for the **draft legislation**, as produced by the federal ministries or as published as **Bundestag or Bundesrat printed papers**, to which the lobbying specifically relates.
- **Federal acts** (“*Bundesgesetze*”): This enables you to search for all existing federal acts and ordinances which are the subject of lobbying and which are referred to in the relevant entries.

All four of these search areas provide a **content search for particular words or parts of words**. As elsewhere, all lists of search results can be refined using additional facet filters and sorted as required.

## 8. Searching for special interests relating to particular bills

It is also possible to **search directly for a specific legislative bill** (ministry draft or printed paper) to find out who is trying to influence it and with what objective and arguments.

If you want to know, for example, what bills there are which relate to “**Cannabis**” and are the subject of lobbying, simply go to Substance of lobbying (“*Inhalte der Interessenvertretung*”) select Regulatory drafts (“*Regelungsentwürfe*”) and type “*Cannabis*” into the search box.

Clicking Search (“*Suchen*”) will then reveal a list of **all the regulatory drafts** which contain the word “*Cannabis*” and are referred to in register entries. These can be further filtered and sorted, e.g. by date of reference (most recent first) (“*Datum der Bezugnahme (absteigend)*”), so that you can quickly find the most current bill.

This allows you see at a glance how many lobbyists are representing special interests in relation to a bill (*“Interessenvertreter/-innen”*), which regulatory proposals have been referred to in that regard (*“Regelungsvorhaben”*) and how many essential written comments or expert opinions which the register contains on the subject (*“Stellungnahmen/Gutachten”*).

The links in square brackets which follow lead to lists of **all the lobbyists actively involved** (*“[alle IV anzeigen]”*), **all the regulatory proposals referred to** (*“[alle RV anzeigen]”*) and **all the relevant comments or expert opinions** which have been uploaded to the register (*“[alle SG anzeigen]”*).

### **9. Your notification account – to keep you up to date!**

If you wish to receive regular **automatic updates by email** when certain register entries are amended or added to, or when new regulatory proposals or comments/expert opinions are added to the register in connection with certain legislative bills, you can sign up for a **notification account** (*“Benachrichtigungskonto”*). This is quick and easy to do: on the home page, go to the **Sign up / Log in** (*“Registrierung/Login”*) submenu and select **Public** (*“Öffentlichkeit”*).




Once you have entered an **email address** (*“Hinterlegte E-Mail-Adresse”*) and set your own **password** (*“Passwort”*), you can set up your account according to what you are interested in.

From your **personal notification account**, you can then select individual notification triggers and the frequency with which you want to receive emails.



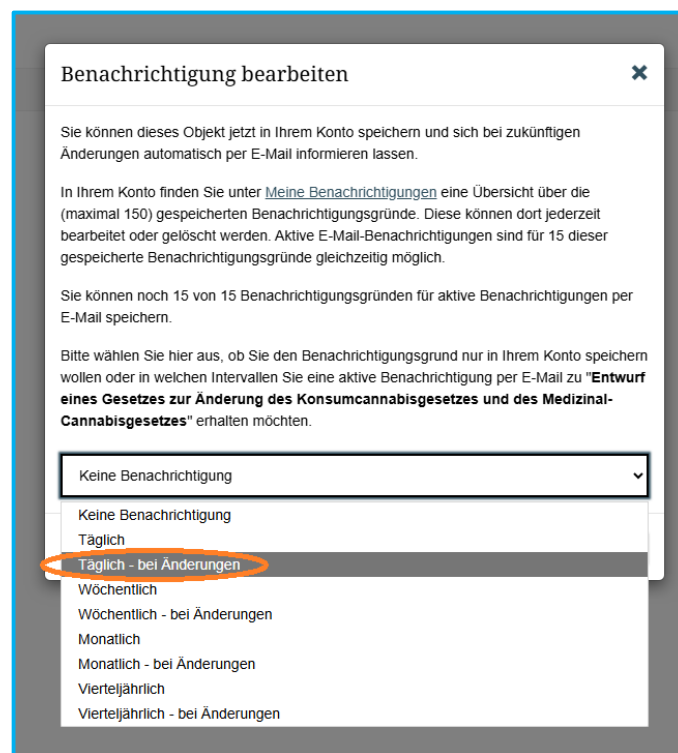

## **10. Open Data/API**

In addition, all the data in the Lobbying Register, including the text content of all essential comments and expert opinions available in the register from lobbyists, can be **downloaded in a machine-readable format**, so that external software may be used for even more customised and detailed analysis.

The data are stored in a carefully structured **JSON format**. JSON, or JavaScript Object Notation, is a machine-readable data format for data interchange between web-based systems.

All publicly available register content can also be accessed via an **API, or application programming interface**. Comprehensive read-only access is provided to the contents of the Lobbying Register. This enables software applications to communicate with each other and exchange data in a structured and automated manner.
